

MLA CITATION

The Modern Language Association (MLA) citation style is used for writing in the arts and humanities. The handbook containing the citation style also discusses research and writing style. There are many copies at LeDoux Library: in the Reference Room and at the Front Desk, among others. All copies are for in-library use only.
