



**POLICY STATEMENT 69**  
**UNIVERSITY OCCUPATIONAL AND ENVIRONMENTAL SAFETY**

**POLICY DIGEST**

**Primary Monitoring Unit: Facility Services**  
**Initially Issued: June 19, 2000**  
**Last Revised: March 18, 2022**

**I. PURPOSE**

To establish a comprehensive occupational and environmental safety policy that facilitates the protection of life and property by providing a campus work and learning environment that is free of recognized hazards that are causing or are likely to cause injury, illness, or property damage.

To set forth safety and environmental responsibilities, provide support for safety rules and procedures, and to establish activities/programs that are necessary for the successful implementation of the University's occupational and environmental safety program.

**II. GENERAL POLICY**

The University has a strong commitment to the health and safety of all employees, students, and visitors at LSU Eunice. Recognizing that a healthy environment is critical to the quality of life of all living organisms, LSU Eunice is committed to protecting the environment from harm due to campus operations and activities. This includes protecting the air, both indoors and out, lakes, and streams and grounds. In keeping with these commitments, the Office of Facility Services shall have the authority to enforce compliance with the requirements referenced in this policy, and other applicable environmental and safety regulations.

Enforcement action will be taken only after consultation with senior administration, unless there is an immediate danger to the health and safety of personnel or an immediate danger to University property. In the event of immediate danger or major noncompliance, the Director of Facility Services will be responsible for taking any actions, including facility closure, required for protection of the health and safety of personnel or protection of University property. The Director of Facility Services will notify central administration of any facility closures. Remedial actions will be required before a closed facility will be reopened.

In keeping with this commitment, the University Occupational and Environmental Safety Policy is as follows:

- A. In the interest of providing the safest environment possible for employees, students and visitors, University activities, including, but not limited to, the design, construction, operation and maintenance of University facilities, will be conducted in accordance with applicable safety codes such as National Fire Protection Association (NFPA), American National Standards Institute (ANSI), American Society of Mechanical Engineers (ASME),

42 and American Society for Testing and Materials (ASTM), and by all governmental safety  
43 and environmental standards, including, but not limited to, those issued by the Louisiana  
44 State Fire Marshal, Occupational Safety and Health Administration (OSHA),  
45 Environmental Protection Agency (EPA), Louisiana Department of Environmental Quality  
46 (LDEQ), Department of Transportation (DOT), Nuclear Regulatory Commission (NRC)  
47 and other similar agencies state, federal, or local agencies. Guidelines of the State  
48 Office of Risk Management (ORM) will form the foundation for the University Safety  
49 Program.

50 B. Safety and environmental rules and procedures in the [LSU Eunice Safety Manual](#) are  
51 very important to the safety program, and shall be vigorously enforced by supervision,  
52 using disciplinary action where appropriate. In addition to enforcement activities,  
53 supervisors are responsible for planning and assigning work that is within the training,  
54 capability, and skills of the workers.

55 C. Critical program elements such as periodic safety inspections, safety training, accident  
56 investigations, and safety meetings shall be implemented for all work groups as outlined  
57 in the [LSU Eunice Safety Manual](#).

58 D. Recognizing that proper training is critical to employee safety, the University will provide  
59 safety and skills training to achieve a highly skilled and safe work force.

### 60 III. ENVIRONMENTAL CONTROL

61 It is the University's intent to provide a safe environment that is conducive to studying, learning,  
62 and working, and to minimize any recognized hazards. Any situation or behavior that disrupts  
63 the studying, learning, or working process, or introduces a hazard, is prohibited. The use of  
64 classrooms for activities other than scheduled classes must first be approved by the Registrar's  
65 Office. Other spaces, such as conference rooms and common spaces may be reserved through  
66 the [Business Office Website](#).<sup>1</sup> Smoking is prohibited in all University learning and working  
67 environments. All animals, except those specifically required for research or teaching purposes,  
68 or those that are ADA approved, are prohibited in all University facilities, including all learning  
69 and working environments. Learning and working environments include classrooms, studios,  
70 laboratories, offices, conference facilities, seminar rooms, practice rooms, libraries, designated  
71 study areas, and carrels.

72 Any person using outdoor areas of the LSU Eunice campus has the responsibility of always  
73 maintaining control of their animals.

### 74 IV. RESPONSIBILITIES

75 A. Each and every employee is responsible for his/her own safety, and for promoting the  
76 safety of their co-workers. Employees must report all safety and environmental concerns  
77 relating to facilities or procedures. Failure to follow appropriate safety standards may  
78 result in disciplinary action, up to and including termination of employment.

79 B. Vice Chancellors, Directors, and Department Heads shall implement the safety and

80 environmental program in their areas of administrative responsibility and shall be  
81 accountable through their areas of administrative channels for the control of accidents  
82 and hazardous exposures in the work environment. They shall also set the example for  
83 environmental control by emphasizing and adopting good environmental practices in  
84 processes and procedures, including, but not limited to, prudent purchasing and the  
85 appropriate use and disposal of chemicals and materials. LSU Eunice is subject to  
86 environmental regulations promulgated and enforced by local, state, and federal  
87 environmental agencies. Any individual or group found to be in violation of these  
88 regulations will be potentially responsible for fines levied by the enforcement authorities  
89 and will be subject to other appropriate corrective action.

90 C. The Director of Facilities Services is the principal provider/coordinator of all University  
91 safety and environmental requirements, including, but not limited to:

- 92 1. Providing resources for the identification, evaluation, and control of hazardous  
93 situations,
- 94 2. Providing safety, security criteria, and assessments for research and teaching labs  
95 working with potentially hazardous chemicals, biological or physical agents or  
96 processes,
- 97 3. Developing and issuing rules and procedures,
- 98 4. Consulting with employees and management, and
- 99 5. Providing safety training, hazardous waste disposal, and occupational safety and  
100 health exposure evaluations.

101 The Director of Facility Services, jointly with environmental permit holders, will monitor  
102 laws and regulatory rules and procedures relating to the environment, act as contact  
103 point for interface with environmental regulatory agencies such as the Louisiana  
104 Department of Environmental Quality (LADEQ), US Environmental Protection Agency  
105 (EPA) and the City of Eunice on regulatory issues, and interface with legal  
106 representatives for the University in citations/disputes on environmental issues.

107 NOTE: Radiation safety is the responsibility of the Radiation Officer on campus.

108 D. The University Safety Committee is an advisory committee reporting to the Director of  
109 Facility Services. The University Safety Committee shall provide recommendations to  
110 the administration that will enhance the University Environmental Health and Safety  
111 Program.

## 112 **V. CHEMICAL USE AND RESEARCH – SAFETY AND SECURITY**

113 Principal investigators and unit heads assure safety and environmental compliance through  
114 activities such as inventory control and reporting as required by Director of Facility Services;  
115 supervising and training laboratory and support workers to assure safety and security;  
116 cooperating with inspections and investigations; and correcting deficiencies identified in these  
117 activities.

## 118 **VI. BIOLOGICAL RESEARCH – SAFETY AND SECURITY**

- 119 Principal investigators' and unit heads' responsibilities include, but are not limited to:
- 120 A. Supervising and directing laboratory and support personnel;
- 121 B. Ensuring that lab personnel have proper training; and
- 122 C. Providing access to labs for inspections and assuring that prompt corrective action is
- 123 employed upon notice of a safety/security violation or concern.
