LSU Eunice seeks to meet these educational and cultural needs by attracting and maintaining an outstanding faculty that will provide a quality educational experience for all students.

11 12 The endowed professorship program is a major effort by the university, the community, the LSU Board of Supervisors, and the Louisiana Board of Regents to demonstrate commitment to quality of instruction by recognizing and fostering faculty excellence in professional projects/research that goes beyond instructional responsibilities. Money has been donated by community sponsors, the United States District Court, and the Board of Regents for these awards.¹ The distribution of these awards will follow the guidelines set forth by the Board of Regents, the LSUE Foundation, and by the current policy statement.

By September 30th of each year, the chair of the Selection Committee for Endowed Professorships will distribute a memorandum to the faculty regarding endowed professorships. This memorandum should include information explaining the professorships and identifying the awards to be granted, the amount of each award for that particular year, and the application process. The amount of each award will be based on interest generated by the funds, as well as fund performance.

Eligibility

To be eligible to apply for an endowed professorship, a faculty member must meet the following
 criteria:

- 1. Hold faculty rank at LSU Eunice.
- 2. Be employed on a full-time basis.
- 3. Be on a tenure track.

29 Division/unit heads, full-time directors, and executive administrators are not eligible.

- Two Lafayette General Medical Center Endowed Professorships, awarded for nursing;
- The Opelousas General Hospital Endowed Professorship, awarded for science in support of nursing;
- The Fritz Lang Endowed Professorship, awarded for science in support of agriculture;
- The BellSouth, Atmos Energy, CenturyTel, CLECO, Entergy Louisiana Endowed Professorship, awarded for public policy.
- Two Train Derailment Endowed Professorships from the United States District Court, Western District of Louisiana, Lafayette-Opelousas Division, awarded in any of the disciplines of Science, Health and Safety, Economics, or Public Policy.

The donors have specified how the award money is to be used:

Duration, Distribution, and Conditions of Awards

- 97 A. Each endowed professorship will be awarded for a period of one year.
- 98 B. Recipients may re-apply in subsequent years.
- 99 C. A recipient will not be granted two concurrent endowments.
- 100 D. The award will become effective the following fiscal year, beginning July 1 and ending June 30.
- 101 E. The award may be used for salary supplements and for expenses directly related to the recipient's project. Order supplies and equipment outlined in the project budget prior to 102 103 submitting the interim report.
- 104 F. The university reserves the right to terminate the award if:
 - 1. the recipient retires, resigns, or otherwise ends full-time employment status.
- 2. the recipient fails to use the funds as described in the recipient's proposal, as determined 107 108 by evaluation of the interim report (as noted below) by the Academic Unit Head and Vice Chancellor for Academic Affairs. 109
- 111 Any funds not spent at the end of the fiscal year will be reinvested in the professorship account.

G. Recipients of endowed professorships will submit an interim report (mid-point in project 113 114 completion) delineating progress in meeting goals, timelines, and project deliverables. The 115 interim report must contain a financial progress report. Recipients are required to submit a final 116 report summarizing sponsored activities and evaluating the effectiveness of the endowed 117 professorship program in supporting excellence in instruction, scholarly/research activity, and 118 community/university service. Receipt of salary supplement (if salary supplement is included in project budget) will be contingent on making satisfactory progress in meeting project goals and 119 120 objectives. The interim and final reports will be submitted to the Vice Chancellor for Academic 121 Affairs, who will distribute copies to the head of the academic division from which the 122 endowment was granted and to the grantor (LSUE Foundation) of the funds.

H. The selection committee chair will forward all funded application proposals to the library after
 completion of the selection process. These proposals will be maintained on file in the library for
 review by interested parties.

- Each applicant selected to receive an Endowed Professorship must attend a training session that will be conducted annually in May.
- J. Any variation in the use of funds from the original budget must be pre-approved by the Vice
 Chancellor for Academic Affairs. Requisitions to spend award funds must be reviewed by the
 Director of Grants and Development to ensure compliance with the project budget.
